Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled, 18ct yellow gold and 18ct white gold, cluster style, gem set, dress ring.

Plain, narrow, tapered band of 2.05mm in width (at base) x 0.71mm depth, with a curved and pierced double 'slot' style underrail.

Feature white gold 'cluster' style setting, housing nine round brilliant cut diamonds, largest to the centre, smallest eight surrounding, all claw set. Secured between the extended shoulders of the yellow gold plain and polished band. Each shoulder having outer extended split terminations, with two round brilliant cut diamonds, claw set in the middle to the band.

Polished finish - stamped '750' - acid tested as 18 carat gold. Finger size is P.

The ring contains:

One claw set round brilliant cut diamond, clarity 'P2', colour 'G'.
Dimensions = 2.40mm(Dia) x 1.46mm(D-estimated) x 2%(Girdle Thickness)
Total Weight = 0.05ct (estimated - see NOTE below)

Twelve claw set round brilliant cut diamonds, clarity 'Si, P1 & P2' (mixed), colour 'G to H' (mixed).
Dimensions = 1.20mm(Dia) x 0.73mm(D-estimated) x 2%(Girdle Thickness) (smallest)
Dimensions = 1.35mm(Dia) x 0.82mm(D-estimated) x 2%(Girdle Thickness) (largest)
Total Weight = 0.11ct (estimated - see NOTE below)



Total Item Weight = 2.54 grams - Total Gemstone Weight = 0.16ct - Total Metal Weight = 2.51 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
