## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, 9ct white gold, multistone, gem set ring, of cast construction.

Plain, narrow, tapered band of 1.49mm in width (at base) x 0.89mm depth.

Feature central 'dome' setting having nineteen round brilliant cut diamonds, tapering in size from largest, claw set. Surrounded by a single outer row of twenty-eight single cut diamonds (smallest), also claw set, with millegrain edging. All secured between the shoulders of the plain and polished band. Each shoulder having four round brilliant cut diamonds, slightly tapering in size, bead set, also with millegrain edging.



Polished finish.

Stamped 'MHJ' - acid tested as approximately 10 carat gold.

Finger size is O 1/2.

The ring contains:

Fifty Five claw set round brilliant cut diamonds, clarity 'Si, P1 & P2' (mixed), colour 'I to J' (mixed).

Dimensions = 0.80mm(Dia) x 0.49mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.90mm(Dia) x 1.16mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.60ct (estimated - see NOTE below)

Total Item Weight = 3.41 grams

Total Gemstone Weight = 0.60ct

Total Metal Weight = 3.28 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
