## Valuation for Traditional Retail Insurance Replacement

## Item 1

One lady's, cast raised sterling silver & diamond set, drop style pendant.

Feature; "cluster style" drop pendant. Comprising, square cushion-shaped step down cluster, housing four round brilliant cut diamonds & sixty nine single cut diamonds, all claw set. Pendant open to back, suspended from a fixed v-shaped enwined style bail to top.

Polished finish, stamped "925, 0.50ct" - acid tested as silver.

Pendant dimensions = 18.94mm (total length) x 11.93mm (width) x 7.28mm (depth).

The pendant contains:

Seventy Three claw set round brilliant cut & single cut diamonds (mixed), clarity is "P3+", colour is "J to K"(mixed), medium cut quality.

Dimensions = 1.00mm (average diameter) x 0.61mm (D-estimated) (smallest)

Dimensions = 1.70mm (average diameter) x 1.04mm (D-estimated) (largest)

Total Weight = 0.50ct (estimated - see NOTE below).

Total Item Weight = 2.41 grams, Total Gemstone Weight = 0.50ct, Total Metal Weight = 2.31 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamond cannot be ascertained. Therefore, weight of the diamond are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamond, would require removal from the setting. The below replacement figure is based upon crafting a similar pendant employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
