Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and 18ct white gold, multistone, gem set ring, of cast construction.

Plain, narrow, tapered band of 1.76mm in width (at base) x 1.05mm depth, with hollow top and shoulders.

Feature central six claw setting, housing one round cut and faceted natural sapphire, claw set. Each shoulder of the yellow gold plain and polished band, having laid-on white gold plates. Each shoulder having one rose cut style diamond, bead set. The top of the ring being of a pierced decorative design.

Polished finish - stamped '18C' - acid tested as 18 carat gold. Finger size is S.

The ring contains:

One claw set round cut and faceted natural sapphire, colour 'dark blue'.

Dimensions = 4.84mm(Dia) x 2.18mm(D-estimated)
Total Weight = 0.37ct (estimated - see NOTE below)

Two bead set rose cut diamonds, clarity 'Si & P1' (mixed), colour 'I to J' (mixed).

Dimensions (average) = 1.85mm(Dia) x 1.02mm(D-estimated) x 2%(Girdle Thickness)
Total Weight = 0.02ct (estimated - see NOTE below)

Total Item Weight = 3.16 grams - Total Gemstone Weight = 0.39ct - Total Metal Weight = 3.08 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring using all modern round brilliant cut diamonds of the same estimated weight, colour and clarity employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
