## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 18ct white gold, multistone, gem set ring, of cast construction.

Plain, narrow band of 2.62mm in width (at base) x 0.77mm depth.

Feature central two 'V' claw setting, housing one marquise cut diamond, 'V' claw set. Secured between the 'cross-over' style shoulders of the plain and polished band. Each shoulder having five round brilliant cut diamonds, two smallest to the centre of each row, all channel set.

Polished finish - stamped '750' - acid tested as 18 carat gold. Finger size is N.

The ring contains:

One 'V' claw set marquise cut diamond, clarity 'Vs', colour 'J'.

Dimensions = 5.44mm(L) x 2.87mm(W) x 1.70mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.16ct (estimated - see NOTE below)

Ten channel set single cut diamonds, clarity 'Vs', colour 'I to J' (mixed).

Dimensions = 1.70mm(diameter) (smallest)

Dimensions = 1.90mm(diameter) (largest)

Total Weight = 0.24ct (estimated - see NOTE below)

Total Item Weight = 3.07 grams - Total Gemstone Weight = 0.40ct - Total Metal Weight = 2.99 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
