Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, hand finished raised, 9ct yellow gold & diamond set ring. Plain, narrow, low half round, tapered band, measures, 2.09mm width (at base) x 0.90mm depth, with cut-out underrail, open back settings, underneath.

Feature, raised double rub-over setting to centre, houses one round brilliant cut diamond, rub-over set. The extended shoulders, of the band tapers up, each shoulder contains three round brilliant cut diamonds, channel set, both sides.

Polished finish, stamped "MHJ 9ct, 16M" - acid tested as 9 carat gold. Finger size = P1/2.

Ring contains;

One rub-over set round brilliant cut diamond, clarity is "Si", colour is "I/J"(inset), medium cut quality.
Dimensions = 2.66mm (diameter) x 1.67mm (D-estimated)
Total Weight = 0.07ct (estimated - see NOTE below).

Six channel set round brilliant cut diamonds, clarity is "Si", colour is "H to I"(mixed), medium cut quality.
Dimensions = 1.58mm (diameter) x 0.96mm (D-estimated)
Total Weight = 0.09ct (estimated - see NOTE below).

Total Item Weight = 2.06 grams, Total Gemstone Weight = 0.16ct, Total Metal Weight = 2.03 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
