## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, lady's hand-assembled raised, 18ct yellow and white gold & diamond set, multistone ring. Plain, narrow, low half round, tapered band, measures 2.12mm width (at base) x 0.85mm depth, with curved underrail.

Feature, "solitaire style" ring design, with shoulder stones. Comprising, a raised six claw white gold setting, houses one round brilliant cut diamond, claw set. The extended shoulders, of the yellow gold band, tapers up to pointed end terminations to both sides. Each shoulder contains one round brilliant cut diamond, bead set, both sides.

Polished finish, stamped "750 DL" - acid tested as 18 carat gold. Finger size = O1/2.

the ring contains;



One claw set round brilliant cut diamond, clarity is "Si", colour is "G to H"(mixed), medium cut quality. Dimensions = 3.42mm (diameter) x 2.09mm (D-estimated) Total Weight = 0.15ct (estimated - see NOTE below).

Two bead set round brilliant cut diamonds, clarity is "Si", colour is "G to H"(mixed), medium cut quality. Dimensions = 1.35mm (average diameter) x 0.82mm (D-estimated) Total Weight = 0.02ct (estimated - see NOTE below).

Total Item Weight = 2.50 grams, Total Gemstone Weight = 0.17ct, Total Metal Weight = 2.47 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
