Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold, multistone, ring set. The set comprising a 18ct yellow gold diamond set engagement ring, with a fitted and matching 18ct yellow gold diamond set wedding ring. Each ring having a plain, narrow, tapered band with a combined basal width of 4.00mm x 0.66mm in depth.

The engagement ring has a semi bezel setting, housing one oval cut and faceted natural ruby, semi rub-over set. Each shoulder having three round brilliant cut diamonds, tapering in size, channel set.

Fitted and matching wedding ring, shaped to sit alongside the engagement ring above.

Polished finish - stamped '750' - acid tested as 18 carat gold. Finger size is P 1/2.

The ring contains:

One semi rub-over set mixed cut oval shape natural ruby, colour 'dark red'.

Dimensions = 5.20mm(L) x 3.73mm(W) x 2.18mm(D-estimated)

Total Weight = 0.36ct (estimated - see NOTE below)

Six channel set round brilliant cut diamonds, clarity 'Si & P1' (mixed), colour 'G to H' (mixed).

Dimensions = 2.25mm(Dia) x 1.37mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.60mm(Dia) x 1.59mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.32ct (estimated - see NOTE below)

Total Item Weight = 4.62 grams - Total Gemstone Weight = 0.68ct - Total Metal Weight = 4.48 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring set employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
