### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, lady's, hand finished, raised 18ct yellow gold & diamond set, solitaire ring, of cast construction.

Plain, narrow, low half round, tapered band, measures 2.39mm width (at base) x 0.73mm depth, with open back, setting, hollowed out shoulders underneath.

Feature, "solitaire style" ring design. Comprising, a raised rhodium plated, rubbed over setting to top. The extended shoulders, of the band, tapers up wide, fluted with a rhodium plate feature to centre, both sides.

Polished finish. Non stamped - acid tested & x-rayed as 18carat gold.

Finger size = K.

The ring contains;

One rub-over set round brilliant cut diamond, clarity is "Si", colour is "G", medium cut quality.  
Dimensions = 3.00mm (diameter) x 1.83mm (D-estimated)  
Total Weight = 0.10ct (estimated - see NOTE below).

Total Item Weight = 3.94 grams, Total Gemstone Weight = 0.10ct, Total Metal Weight = 3.92 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamond cannot be ascertained. Therefore, weight of the diamond are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamond, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
