## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, lady's hand-assembled raised, 18ct yellow gold & diamond set, cluster ring. Plain, narrow, low half round, tapered band, measures 1.35mm width (at base) x 1.29mm depth, with curved underrail.

Feature, 'circular cluster style" ring design. Comprising, a peirced out bowl, with a multi claw setting to centre, drops to a bead set surround. The extended shoulders, of the band, tapers slighlty up to the base of the cluster, from both sides.



Polished finish, stamped "750" - acid tested as 18 carat gold. Finger size = K1/2.

The ring contains;

One claw set round brilliant cut diamond (laser inscribed & certified), clarity is "Si1", colour is "D", excellent cut quality. Dimensions = 5.62 - 5.61mm (diameter) x 3.39mm (D-estimated) x 4%(Girdle Thickness)

Total Weight = 0.65ct (known weight - see NOTE below).

Fifteen bead set round brilliant cut diamonds, clarity is "Vs, Si & P2"(mixed), colour is "G to H"(mixed), medium cut quality. Dimensions = 1.10mm (average diameter) x 0.67mm (D-estimated)
Total Weight = 0.08ct (estimated - see NOTE below).

Total Item Weight = 2.41 grams, Total Gemstone Weight = 0.73ct, Total Metal Weight = 2.27 grams, (estimated)

NOTE: Limited gemmological testing, inset. NOTE: The centre diamond has been certified by, and is the opinion of, Messrs. Gemological Institute of America, Certificate no. 130831144. Dated August 24,2018 The diamond has also been laser inscribed upon the girdle with GIA (logo) and 130831144. NOTE: Due to setting constraints, the exact dimensions of the other diamonds cannot be ascertained. Therefore, weight of the other diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the other diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
