Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and 18ct white gold, gem set, multistone ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 3.74mm width (at base) x 1.12mm depth, with open back settings, and a curved underrail.

Feature five white gold bezel settings, each housing one round brilliant cut diamond, spanning across the top of the band, graduating in size, largest to the centre, and bezel set. The settings are secured to the top of the yellow gold band. Framing the central settings to the top and the bottom, is one row of twelve round brilliant cut diamonds, channel set.

Polished finish.

Stamped '750 S' - acid tested as 18 carat gold.

Ring size: H.

The ring contains:

One bezel set round brilliant cut diamond, clarity is "Si1", colour is "H".

Dimensions = 3.19mm(Dia) x 1.95mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.12ct (estimated - see NOTE below)

Four bezel and channel set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "H to I" (mixed).

Dimensions = 1.15mm(Dia) x 0.7mm(D-estimated) x 2%(Girdle Thickness) (smallest)

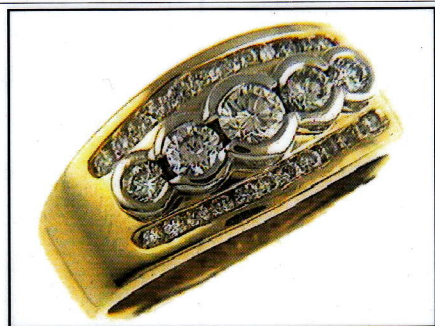
Dimensions = 2.70mm(Dia) x 1.65mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.38ct (estimated - see NOTE below)

Total Item Weight = 5.47 grams Total Gemstone Weight = 0.50ct Total Metal Weight = 5.37 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
