Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, multistone ring, of cast construction.

Plain, narrow, low half round, tapered band of 2.19mm width (at base) x 1.19mm depth, with open back (cut out) settings.

Feature central 'cross over' style setting, housing one Princess cut diamond, end set. The setting is created with the extended and square shoulders, of the plain and polished band. Each of the shoulders houses one row of five Princess cut diamonds, graduating in size, and channel set.

Polished finish

Stamped '750 SA & C' - acid tested as 18 carat gold.

Ring size: H.

The ring contains:

One end set Princess cut diamond, clarity is "Si1", colour is "J".

Dimensions = 4.25mm(L) x 4.21mm(W) x 3.20mm(D-estimated) x 3%(Girdle Thickness)

Total Weight = 0.50ct (estimated - see NOTE below)

Ten channel set Princess cut diamonds, clarity is "Si & P1", colour is "J to K" (mixed).

Dimensions = 1.80mm(L) x 1.80mm(W) x 1.28mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.18mm(L) x 2.18mm(W) x 1.55mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.50ct (estimated - see NOTE below)



Total Item Weight = 4.64 grams Total Gemstone Weight = 1.00ct Total Metal Weight = 4.44 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
