Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and 18ct white gold, gem set, multistone ring, of hand-assembled construction. Plain, narrow, low half round band of 1.93mm width (at base) x 1.27mm depth, with open back (cut out) settings, and a curved underrail.

Feature central white gold four claw setting, housing one Princess cut diamond, claw set. The setting is secured to the underrail, and in between the extended and square shoulders, of the plain and polished yellow gold band. Each of the shoulders, houses one row of seven Princess cut diamond, channel set.

Polished finish.

Stamped '18ct T' - acid tested as 18 carat gold.

Ring size: J.

The ring contains:

One claw set Princess cut diamond, clarity is "Vs2", colour is "D". Dimensions = 4.73mm(L) x 4.60mm(W) x 3.24mm(D-estimated) x 3.5%(Girdle Thickness)

Total Weight = 0.57ct (estimated - see NOTE below)

Fourteen channel set Princess cut diamonds, clarity is "Vs & Si" (mixed), colour is "G to H" (mixed). Dimensions = 1.55mm(L) x 1.55mm(W) x 1.10mm(D-estimated) x 2%(Girdle Thickness) Total Weight = 0.30ct (estimated - see NOTE below)

Total Item Weight = 2.87 grams Total Gemstone Weight = 0.87ct Total Metal Weight = 2.71 grams (estimated)

NOTE: The diamond has been certified by Messrs. Gemological Institute of America (GIA) Certificate number: 2161347949 Dated: July 11, 2014. The diamond has also been laser inscribed upon the girdle with GIA (logo) and 2161347949. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
