Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and 18ct white gold, gem set, 'solitaire' style ring, of handmade construction.

Plain, narrow, low half round, tapered band of 2.56mm width (at base) x 0.92mm depth, with a curved underrail.

Feature central white gold illusion setting, housing one round brilliant cut diamond, illusion set. The setting is secured to the decorative gallery, and in between the extended and tapering shoulders, of the plain and polished yellow gold band. Each of the shoulders is embellished with one groove down the centre.

Polished finish. Stamped '18CT' - acid tested as 18 carat gold.

Ring size: Q.

The ring contains:

One illusion set round brilliant cut diamond, clarity is "Si2", colour is "G".
Dimensions = 4.30mm(Dia) x 2.80mm(D-estimated) x 2%(Girdle Thickness)
Total Weight = 0.32ct (estimated - see NOTE below)

Total Item Weight = 3.45 grams
Total Gemstone Weight = 0.32ct
Total Metal Weight = 3.39 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
