Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, hand finished, raised 14ct white gold & diamond set, multistone ring. Plain, narrow, low half round, tapered band, measures, 1.38mm width (at base) x 1.11mm depth, with cut-out underrail.

Feature, 'cluster style" ring design, with shoulder stones. Comprising, a raised multi claw setting to top & centre, housing, eleven round brilliant cut diamonds (mixed) sizes, illusion claw set. Drops to a surround, containing twenty round brilliant cut diamonds, claw set. The extended shoulders, of the band tapers up to the top, from both sides, each contain five round brilliant cut diamonds, claw set.



Polished finish, stamped "14K, 1.00 michael hill" - acid tested as 14 carat gold.

Finger size = P.

The ring contains;

Six claw set round brilliant cut diamonds, clarity is "P1 & P2" (mixed), colour is "H to I" (mixed), medium cut quality.

Dimensions = 2.90mm (average diameter) x 1.77mm (D-estimated)

Total Weight = 0.60ct (estimated - see NOTE below).

Thirty Five claw set round brilliant cut diamonds, clarity is "P1 & P2"(mixed), colour is "H to I"(mixed), medium cut quality.

Dimensions = 1.25mm (average diameter) x 0.76mm (D-estimated) (smallest)

Dimensions = 1.45mm (average diameter) x 0.88mm (D-estimated) (largest)

Total Weight = 0.40ct (estimated - see NOTE below).

Total Item Weight = 3.03 grams, Total Gemstone Weight = 1.00ct, Total Metal Weight = 2.83 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
