Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct white gold and 9ct yellow gold, gem set, pendant, of hand-assembled construction.

Feature three vertical white gold, railed shared claw settings, each housing one round brilliant cut diamond, claw set. The pendant is finished with an articulated yellow gold tapered bail.

Pendant dimensions = 22.50mm (ave. length) x 4.20mm (ave. width) x 4.10mm (ave. depth).

Polished finish.

Stamped '375' - acid tested as 9 carat gold.

The item contains:

Three claw set round brilliant cut diamonds, clarity is "P1 & P2" (mixed), colour is "G to H" (mixed). Dimensions = 3.56mm(Dia) x 2.17mm(D-estimated) x 3%(Girdle Thickness) (smallest) Dimensions = 4.44mm(Dia) x 2.71mm(D-estimated) x 3%(Girdle Thickness) (largest) Total Weight = 0.75ct (estimated - see NOTE below)

Total Item Weight = 1.14 grams Total Gemstone Weight = 0.75ct Total Metal Weight = 0.99 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pendant employing similar materials and techniques being for a retail insurance purpose only.
