## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, gents raised 10ct yellow gold & diamond set, multistone ring, of cast construction. Plain, wide, low half round, tapered band, measures 3.57mm width (at base) x 1.49mm depth, with cut-out underrail, open back settings, underneath.

Feature, "cluster style" dress ring. Comprising, a square-shaped cluster to top. Housing nine round, black faceted diamonds, bead set. Drops to a surround containing twenty six round brilliant cut diamonds, bead set. The extended shoulders, of the band tapers up to the top. Each shoulder having a frosted ripple centre motif, to both sides.

Polished finish, stamped "10K 0.75 TDW, michael hill" - acid tested approximately 10 carat gold.

Finger size = Z+5.

The ring contains;

Nine bead set round brilliant cut diamonds, colour is "black", medium cut quality.

Dimensions = 2.48mm (average diameter) x 1.51mm (D-estimated)

Total Weight = 0.49ct (estimated - see NOTE below).

Twenty Six bead set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "H to I" (mixed), medium cut quality.

Dimensions = 1.29mm (average diameter) x 0.79mm (D-estimated)

Total Weight = 0.26ct (estimated - see NOTE below).

Total Item Weight = 9.34 grams, Total Gemstone Weight = 0.75ct, Total Metal Weight = 9.15 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
