Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and 18ct white gold, gem set, 'three stone' style ring, of hand-assembled construction.

Plain, narrow, half round band of 2.76mm width (at base) x 1.13mm depth, with open back settings, and a curved underrail.

Feature three railed white gold shared claw settings, spanning across the top of the band, each housing one round brilliant cut diamond, claw set. The settings are secured to the underrail, and in between the extended and pointed shoulders, of the plain and polished yellow gold band.

Polished finish.

Stamped '750 .51ct MM(engraved)' - acid tested as 18 carat gold.

Ring size: M 1/2.

The ring size:

Three claw set round brilliant cut diamonds, clarity is "P1 & P2" (mixed), colour is "H to I" (mixed). Dimensions = 3.60mm(Dia) x 2.20mm(D-estimated) x 2%(Girdle Thickness) (smallest) Dimensions = 3.70mm(Dia) x 2.26mm(D-estimated) x 2%(Girdle Thickness) (largest) Total Weight = 0.51ct (estimated - see NOTE below)

Total Item Weight = 3.76 grams Total Gemstone Weight = 0.51ct Total Metal Weight = 3.66 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
