## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, 10ct white gold, gem set, oval solid hinged bangle, of hand-assembled construction.

Feature alternating, one larger round brilliant cut diamond with two smaller round brilliant cut diamonds, spanning across the top of the front panel, claw set. There are a total of twenty-five larger round brilliant cut diamonds, and forty-eight smaller round brilliant cut diamonds. The bangle is finished with a box clasp and a figure 8 safety catch.

Bangle dimensions = 66.00mm (ave. length) x 56.00mm (ave. width) x 2.47mm (ave. depth).

Polished finish.

Stamped '10K 1.00 MHJ' - acid tested as 9 carat gold.

The item contains:

- Twenty Five claw set round brilliant cut diamonds, clarity is "P1 & P2 & P3" (mixed), colour is "H to J" (mixed).
  - Dimensions = 1.90mm(Dia) x 1.16mm(D-estimated) x 2%(Girdle Thickness) (smallest)
  - Dimensions = 2.10mm(Dia) x 1.28mm(D-estimated) x 2%(Girdle Thickness) (largest)
  - Total Weight = 0.75ct (estimated see NOTE below)

Forty Eight claw set single cut diamonds, clarity is "P1 & P2 & P3" (mixed), colour is "H to J" (mixed)

Dimensions = 1.00mm (diameter) (smallest)

Dimensions = 1.10mm (diameter) (largest)

Total Weight = 0.25ct (estimated - see NOTE below)

Total Item Weight = 7.98 grams Total Gemstone Weight = 1.00ct Total Metal Weight = 7.78 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar bangle employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
