Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand-assembled raised, 18ct white gold & gemstone set, cluster ring. Plain, narrow, low half round, tapered band, measures 2.15mm width (at base) x 1.34mm depth, with curved underrail.

Feature, "cluster style" ring design, with shoulder stones. Comprising, a raised three claw setting to top, centre, houses one pear-shaped, morganite stone, claw set. Drops to a pearshaped surround, contains ninteen round brilliant cut diamonds, claw set. The extended shoulders, of the band, tapers up to the top, each shoulder containing four round brilliant cut diamonds, claw set.



Polished finish, stamped "750" - acid tested as 18 carat gold.

Finger size = J.

The ring contains;

One claw set pear-shaped, natural morganite, colour is "extremely light peach/pink". Dimensions = 10.15mm (L) x 8.01mm (W) x 4.81mm (D-estimated) Total Weight = 2.13ct (estimated - see NOTE below).

Twenty Seven claw set round brilliant cut diamonds, clarity is "Si", colour is "G to H"(mixed), medium cut quality. Dimensions = 1.54mm (average diameter) x 0.94mm (D-estimated)

Total Weight = 0.38ct (estimated - see NOTE below).

Total Item Weight = 7.23 grams, Total Gemstone Weight = 2.51ct, Total Metal Weight = 6.73 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
