One lady's, hand finished raised 18ct yellow gold & gemstone set, solitaire style ring.

Plain, narrow, low half round, tapered band, measures 1.57mm width (at base) x 1.57mm depth, with curved underrail.

Feature, "solitaire style" ring design. Comprising, a raised four claw setting to top, housing, one Princess cut 'laboratory grown synthetic diamond' laser inscribed, claw set. The extended shoulders, of the band, tapers up to the top, from both sides.

Polished finish, stamped "750" - acid tested as 18 carat gold.

Finger size = O.

The ring contains;

One claw set Princess cut 'laboratory grown synthetic diamond', clarity is "Si1", colour is "E", excellent cut quality.
Dimensions = 5.00mm (L) x 4.97mm (W) x 3.61mm (D-estimated)
Total Weight = 0.78ct (known - see NOTE below).

Total Item Weight = 3.04grams, Total Gemstone Weight = 0.78ct, Total Metal Weight = 2.88 grams. (estimated)

NOTE: No certificate presented at the time of this valuation. However, the "laboratory grown synthetic diamond" has been certified by, and is the opinion of, Messrs. International Gemological Institute, Certificate no. LG514254400 Dated January 25, 2022. The "laboratory grown synthetic diamond" has also been laser inscribed upon the girdle with IGI (logo) and 'Labgrown IGI LG514254400'. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
