### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, 9ct white gold, gem set, 'cluster' style ring, of cast construction.

Plain, narrow, low half round band of 2.28mm width (at base) x 1.32mm depth, with a curved underrail.

Feature central bezel setting, housing one round brilliant cut diamond, bezel set. Surrounding is one row of fourteen round brilliant cut diamonds, claw set. The top plate is supported with a pierced decorative gallery, and is secured between the extended and square shoulders, of the plain and polished band. Each of the shoulders houses one row of six round brilliant cut diamonds, claw set.

Polished finish.

Stamped '375 unknown makers mark' - acid tested as 9 carat gold.

The ring contains:

One bezel set round brilliant cut diamond, clarity is "P1", colour is "K".

Dimensions = 4.00mm(Dia) x 2.44mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.23ct (estimated - see NOTE below)

Twenty Six claw set round brilliant cut diamonds, clarity is "Vs & Si & P1" (mixed), colour is "G to K" (mixed).

Dimensions = 1.30mm(Dia) x 0.79mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.50mm(Dia) x 0.92mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.77ct (estimated - see NOTE below)

Total Item Weight = 3.57 grams Total Gemstone Weight = 1.00ct Total Metal Weight = 3.38 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
