Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand assembled, 18ct white gold, multi-stone, ring set, of cast construction.

The set comprising a 18ct white gold diamond set engagement ring with a fitted and matching 18ct white gold diamond set wedding and eternity rings. Each ring having a plain, narrow, low half round, tapered band with a combined basal width of 5.31mm x 1.08mm in depth.

The engagement ring has a central six claw setting, housing one round brilliant cut diamond, claw set. Each of the shoulders is embellished with a three claw setting, housing one round brilliant cut diamond, claw set. The settings are secured between the shoulders of the plain and polished band.



The fitted and matching wedding and eternity rings are identical. There is one row of sixteen round brilliant cut diamonds, spanning across the top of the band, graduating in size, largest to the centre, and claw set. There is a small curve in the centre of the band. The wedding and eternity rings sit alongside the engagement ring above.

Polished finish. Stamped '18ct TJG 0.20' - acid tested as 18 carat gold. Ring size: N.

The ring contains:

Two claw set round brilliant cut diamonds, clarity is "P2", colour is "G to H" (mixed).

Dimensions = 2.60mm(Dia) x 1.59mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 4.79mm(L) x 4.77mm(W) x 3.21mm(D-estimated) x 4%(Girdle Thickness)(largest)

Total Weight = 0.60ct (estimated - see NOTE below)

Thirty Two claw set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "G to H" (mixed).

Dimensions = 1.27mm(Dia) x 0.77mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.66mm(Dia) x 1.01mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.40ct (estimated - see NOTE below)

Total Item Weight = 6.70 grams Total Gemstone Weight = 1.00ct Total Metal Weight = 6.50 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring set employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
