Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand-assembled raised, 18ct white gold & gemset, multistone ring. Plain, narrow, low half round, tapered band, measures 3.89mm width (at base) x 1.38mm depth, with curved underrail.

Feature, "cluster style" ring design. Comprising, a u-shaped centre with a cluster setting, above, housing nine round brilliant cut diamonds, claw & illusion claw set. The extended shoulders, of the band sweep up to the top, from both sides.

Polished finish, stamped "750" - acid tested as 18 carat gold. Finger size = T.

The ring contains;

One illusion claw set round brilliant cut diamond, clarity is "Vs", colour is "H", medium cut quality.
Dimensions = 2.96mm (average diameter) x 1.81mm (D-estimated)
Total Weight = 0.10ct (estimated - see NOTE below).

Eight claw set round brilliant cut diamonds, clarity is "Vs", colour is "G to H"(mixed), medium cut quality.
Dimensions = 2.16mm (average diameter) x 1.32mm (D-estimated)
Total Weight = 0.30ct (estimated - see NOTE below).

Total Item Weight = 7.70 grams, Total Gemstone Weight = 0.40ct, Total Metal Weight = 7.62 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
