## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, lady's hand-assembled raised, 18ct white gold & gemset, multistone ring. Plain, narrow, low half round, tapered band, measures 2.95mm width (at base) x 1.06mm depth, with open back, underneath.

Feature, "cluster style" ring design. Comprising, a raised rub-over setting to centre, houses one round brilliant cut diamond, rub-over set. Drops to a surround, contains twelve round brilliant cut diamonds, bead set. The extended shoulders, of the band tapers up to the top, from both sides.



Polished finish, stamped "750" - acid tested as 18 carat gold. Finger size = S1/2.

The ring contains;

One rub-over set round brilliant cut diamond, clarity is "Si", colour is "H", medium cut quality.

Dimensions = 4.20mm (average diameter) x 2.45mm (D-estimated)

Total Weight = 0.30ct (estimated - see NOTE below).

Twelve bead set round brilliant cut diamonds, clarity is "Si", colour is "H", medium cut quality.

Dimensions = 1.60mm (average diameter) x 0.98mm (D-estimated)

Total Weight = 0.20ct (estimated - see NOTE below).

Total Item Weight = 4.49 grams, Total Gemstone Weight = 0.50ct, Total Metal Weight = 4.39 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
