Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand-assembled raised, 18ct white gold & gemset, three stone ring. Plain, narrow, low half round, tapered band, measures 2.04mm width (at base) x 1.29mm 1.29mm depth, with curved underrail.

Feature, "trilogy style" ring design. Comprising, a trilogy claw setting to top, houses three round brilliant cut diamonds, claw set. The extended shoulders, of the band, tapers up to pointed end terminations, to both sides.

Polished finish, stamped "750 CD" - acid tested as 18 carat gold.

Finger size = L1/2.

The ring contains;

Three claw set round brilliant cut diamonds, clarity is "Vs", colour is "H", medium cut quality. Dimensions = 3.21mm (average diameter) x 1.96mm (D-estimated) (smallest) Dimensions = 3.52mm (average diameter) x 2.05mm (D-estimated) (largest) Total Weight = 0.40ct (estimated - see NOTE below).

Total Item Weight = 2.66 grams, Total Gemstone Weight = 0.40ct, Total Metal Weight = 2.58 grams (estimated)

NOTE: Limited gemmological testing, isnet. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
