## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 18ct yellow gold, gem set, multistone ring, of hand-assembled construction.

Plain, wide, flat, tapered band of 4.52mm width (at base) x 1.02mm depth, with open back settings.

Feature rectangle top plate, housing one row of four round brilliant cut diamonds, graduating in size, and bead set. To the bottom of the diamonds, the top plate is sliced on an angle. The top plate is secured between the tapering shoulders, of the plain and polished band.

Polished finish.

Stamped '750 RHP' - acid tested as 18 carat gold.

Ring size: X.

The ring contains:

Four bead set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "G to H" (mixed).

Dimensions = 1.80mm(Dia) x 1.10mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 3.10mm(Dia) x 1.89mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.27ct (estimated - see NOTE below)

Total Item Weight = 10.59 grams

Total Gemstone Weight = 0.27ct

Total Metal Weight = 10.54 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
