Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold and 18ct yellow gold, gem set, 'solitaire' syle ring, of hand assembled construction.

Plain, narrow, flat band of 2.74mm width (at base) x 1.06mm depth.

Feature central white gold illusion plate, within a four claw setting, housing one round brilliant cut diamond, illusion set. The setting and white gold shoulder plates, are secured to the top of the plain and polished yellow gold band.



Polished finish.

Stamped '18CT' - acid tested as 18 carat gold.

Ring size: P.

The ring contains:

One illusion set round brilliant cut diamond, clarity is "Vs", colour is "G".

Dimensions = 3.29mm(Dia) x 1.85mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.14ct (estimated - see NOTE below)

Total Item Weight = 3.55 grams

Total Gemstone Weight = 0.14ct

Total Metal Weight = 3.52 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
