### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, lady's raised, 18ct yellow gold & diamond set, three stone ring. Plain, narrow, low half round, tapered band, measures 1.55mm width (at base) x 0.90mm depth, with curved underrail.

Feature, "trilogy grouped" style. Comprising, three, four claw settings, multi level, housing three round brilliant cut diamonds, claw set. The extended shoulders, of the band, tapers up to pointed end terminations to both sides.

Polished finish, stamped "18ct (partial)" - acid tested as 18 carat gold.

Finger size = R.

The ring contains:

Three claw set round brilliant cut diamonds, clarity is "Si", colour is "G to I" (mixed), medium cut quality.

Dimensions - 2.20mm (average diameter) x 1.34mm (D-estimated) (smallest)

Dimensions - 2.80mm (average diameter) x 1.71mm (D-estimated) (largest)

Total Weight - 0.20ct (estimated - see NOTE below).

Total Item Weight - 2.50 grams, Total Gemstone Weight = 0.20ct, Total Metal Weight = 2.46 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
