Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, hand finished, raised 9ct white gold & diamond set, cluster dress ring. Plain, narrow, low half round, tapered band, measures, 1.60mm width (at base) x 1.08mm depth, with curved underrail.

Feature, square cushion-shaped setting to top, houses nine round brilliant cut diamonds, claw set. Drops to a surround, contains twenty four round brilliant cut diamonds, claw set. The extended shoulders, of the band, tapers up. Each shoulder containing, four round brilliant cut diamonds, claw set, both sides.

Polished finish, stamped "9K, JP51" - acid tested as 9 carat gold. Finger size = O.



The ring contains;

Five claw set round brilliant cut diamonds, clarity is "P1 & P2"(mixed), colour is "H to I"(mixed), medium cut quality.

Dimensions = 2.30mm (average diameter) x 1.40mm (D-estimated) (smallest)

Dimensions = 2.70mm (average diameter) x 1.65mm (D-estimated) (largest)

Total Weight = 0.25ct (estimated - see NOTE below).

Thirty Six claw set round brilliant cut diamonds, clarity is "P1 & P2"(mixed), colour is "H to I"(mixed), medium cut quality.

Dimensions = 1.15mm (average diameter) x 0.70mm (D-estimated) (smallest)

Dimensions = 1.56mm (average diameter) x 0.95mm (D-estimated) (largest)

Total Weight = 0.25ct (estimated - see NOTE below).

Total Item Weight = 2.90 grams, Total Gemstone Weight = 0.50ct, Total Metal Weight = 2.80 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
