Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled, 9ct white gold, multistone, gem set ring. Plain, narrow, tapered band of 2.03mm in width (at base) x 0.93mm depth, with closed back settings.

Feature central bezel setting, housing six Princess cut diamonds, invisible set in two vertical rows. Surrounded by fourteen round brilliant cut diamonds, smallest to each corner, claw set. Solid setting sides, all secured between the split shoulders of the plain and polished band. Each shoulder having a total of eight round brilliant cut diamonds, also claw set.

Polished finish - stamped '375' - acid tested as 9 carat gold. Finger size is K 1/2.

The ring contains:

Six invisible set Princess cut diamonds, clarity 'Vs & Si' (mixed), colour 'G to H' (mixed).
Dimensions (average) = 1.95mm(L) x 1.95mm(W) x 1.15mm(D-estimated) x 2%(Girdle Thickness)
Total Weight = 0.26ct (estimated - see NOTE below)

Thirty claw set round brilliant cut diamonds, clarity 'Vs, Si & P1' (mixed), colour 'G to I' (mixed).
Dimensions = 1.05mm(Dia) x 0.64mm(D-estimated) x 2%(Girdle Thickness) (smallest)
Dimensions = 1.15mm(Dia) x 0.70mm(D-estimated) x 2%(Girdle Thickness) (largest)
Total Weight = 0.24ct (estimated - see NOTE below)

Total Item Weight = 2.96 grams - Total Gemstone Weight = 0.50ct - Total Metal Weight = 2.86 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
