### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, hand-assembled, 18ct white gold, multistone, gem set ring.

Plain, narrow, tapered band of 1.41mm in width (at base) x 1.03mm depth, with open back settings, and shoulders.

Feature three individual, four claw railed settings, each housing one round brilliant cut diamond, largest to the centre, all claw set. Each shoulder having three round brilliant cut diamonds, channel set.

Polished finish - stamped '750' - acid tested as 18 carat gold. Finger size is M.

The ring contains:

Three claw set round brilliant cut diamonds, clarity 'P1', colour 'G to H' (mixed).

Dimensions = 2.83mm(Dia) x 1.73mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 3.10mm(Dia) x 1.89mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.27ct (estimated - see NOTE below)

Six channel set round brilliant cut diamonds, clarity 'Si & P1' (mixed), colour 'G'.

Dimensions (average) = 1.45mm(Dia) x 0.88mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.08ct (estimated - see NOTE below)

Total Item Weight = 2.64 grams - Total Gemstone Weight = 0.35ct - Total Metal Weight = 2.57 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
