Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand finished raised, 9ct yellow and white gold & diamond set, multistone ring.

Plain, wide, low half round, tapered band, measures, 7.62mm width (at base) x 1.27mm depth, with curved underrail.

Feature; "trilogy style" design. Comprising, a raised rub-over setting, to centre, houses one round brilliant cut diamond, rub-over set. To each side set into the yellow gold section, two round brilliant cut diamonds, rub-over set flush to metal. a cut out d-shaped white gold section, to each side & runs parallel through the centre of the band.



Polished finish, stamped "375 AGR AJ02" - acid tested as 9 carat gold. Finger size = Q.

The ring contains;

One rub-over set round brilliant cut diamond, clarity is "P1", colour is "I", medium cut quality.

Dimensions = 3.40mm (average diameter) x 2.07mm (D-estimated)

Total Weight = 0.15ct (estimated - see NOTE below).

Two rub-over set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "H to I"(mixed), medium cut quality.

Dimensions = 2.40mm (average diameter) x 1.46mm (D-estimated)

Total Weight = 0.10ct (estimated - see NOTE below).

Total Item Weight = 6.16 grams, Total Gemstone Weight = 0.25ct, Total Metal Weight = 6.11 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
