Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand-assembled raised, 10ct yellow and white gold drop style open heart-shaped pendant.

Feature; "open heart" style pendant. Comprising, a yellow gold open heart, houses twenty eight round brilliant cut diamonds, channel set. To the top, suspended from a hinged white gold, v-shaped bail, contains three round brilliant cut diamonds, tapering sizes, channel set.

Polished finish, stamped "MHJ 10K" - acid tested approximately 10 carat gold.

Pendant dimensions = 30.00mm (length) x 25.00mm (width) x 3.95mm (depth).

The pendant contains:

Three channel set round brilliant cut diamonds, clarity is "Si", colour is "H to J"(mixed), medium cut quality.
Dimensions = 1.40mm (average diameter) x 0.85mm (D-estimated) (smallest)
Dimensions = 2.60mm (average diameter) x 1.59mm (D-estimated) (largest)
Total Weight = 0.10ct (estimated - see NOTE below).

Twenty Eight channel set round brilliant cut diamonds, clarity is "SI", colour is "H-J", medium cut quality.
Dimensions = 1.90mm (average diameter) x 1.16mm (D-estimated) (smallest)
Dimensions = 2.10mm (average diameter) x 1.28mm (D-estimated) (largest)
Total Weight = 0.84ct (estimated - see NOTE below).

Total Item Weight = 4.28 grams, Total Gemstone Weight = 0.94ct, Total Metal Weight = 4.09 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
