One lady's stamped (14k Sir Michael Hill 314819671 0.87) 14ct white gold and rose gold double halo ring with diamonds and pink sapphires.

Weight: 3.31 grams.

Manufacture: Cast and hand finished.

Total diamond weight: 0.87ct.

1 x three claw set pear shaped diamond, surrounded lower by two rows of micropave set diamonds in pear shaped halo's, and with micropave set diamonds and 2 x bezel set pink sapphires to the claws/underrail. Micropave set diamonds amongst the shoulders. Tapering half round band with upswept shoulders: 2.1-1.8mm wide. Finger size "N".

Diamonds – 1 x pear brilliant cut, 5.96x3.69x2.36mm, I colour, I1 clarity, excellent polish, very good symmetry, no fluorescence, 0.30ct as per the IGI Diamond Report and laser inscription no."IGI 314819671".
