18ct White Gold Diamond Ring

The rings setting head features five pairs of channel set round brilliant cut diamonds that graduate towards the centre in size. Beneath each pair is another pair of round brilliant cut diamonds in channel settings. The ¼ rounded profile band tapers from 4.70mm to 2.90mm at base. The inside of the ring is laser inscribed "MHJ", "18CT" and "1.00".
