Description

18ct White Gold, Topaz, Citrine and Diamond Ring

The centre of the ring contains a five-claw set round brilliant cut sapphire surrounded by five pear modified brilliant cut topaz. The split shoulders each contain a pattern of round brilliant cut Citrine and diamonds, each in a two-claw setting. The shoulders transition down into the tapered band, measuring from 6.50mm down to 2.60mm at base. The inside of the ring is stamped "750".

Topaz information:

5 = Shape/cut; pear modified brilliant. Measurement; 4.50 x 3.00mm. Colour; strong medium blue. Clarity; eye clean.

Citrine information:

12 = Shape/cut; round modified brilliant. Measurement; 2.00mm. Colour; dark orange. Clarity; eye clean.

Diamonds information:

1 = 0.03 carat (estimated weight). Shape/cut; round brilliant. Measurement; 2.00mm. Colour; I. Clarity; SI.

6 = 0.15 carat (estimated weight). Shape/cut; round brilliant. Measurement; 1.75mm. Colour; I-J. Clarity; SI.

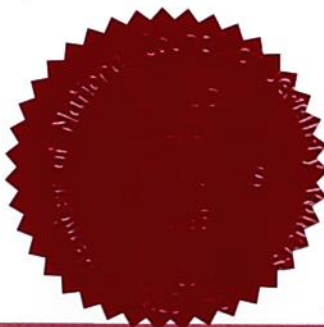
