Set with 1 x 6.00mm x 4.00mm [0.40mct] pear cut diamond end cap and 2 claw set in a raised setting surrounded by 17 x 0.80mm [0.005mct] and 20 x 1.20mm [0.008mct] round brilliant cut diamonds 4 claw castle set in the halo with 24 x 1.10mm [0.007mct] and 8 x 1.00mm [0.006mct] round brilliant cut diamonds 4 claw castle set in the shoulders.  
The shank is rounded and tapers from 3.10mm - 2.00mm wide.  
The fitted wedding ring is set with 19 x 1.50mm [0.015mct] round brilliant cut diamonds 4 claw castle set in the thickened top.  
The shank is rounded and tapers from 1.80mm - 1.65mm wide.
