Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's, hand-assembled raised, 18ct white gold & diamond set, solitaire ring. Plain, narrow, low half round, tapered band, measures 2.1mm width (at base) x 1.21mm depth, with curved underrail.

Feature, "solitaire style" ring design. Comprising, a raised four claw setting, houses one Princess cut diamond (laser inscribed & certified), claw set. The extended shoulders, of the band, tapers slightly at the top, from both sides.

Polished finish, stamped "750" [] - acid tested as 18 carat gold.

Finger size = K1/2.

The ring contains;

One claw set Princess cut diamond (laser inscribed & certified), clarity is "Si1", colour is "G", medium cut quality.
Dimensions = 4.44mm (L) x 4.31mm (W) x 3.13mm (D-estimated) x 5%(Girdle Thickness)
Total Weight = 0.52ct (estimated - see NOTE below).



Total Item Weight = 3.03 grams, Total Gemstone Weight = 0.52ct, Total Metal Weight = 2.93 grams (estimated)

NOTE: The Princess cut diamond, has been certified by, and is the opinion of, Messrs. Gemological Institute of America, Certificate no.1345626727. Dated January, 21, 2020. The diamond has also been laser inscribed upon the girdle with GIA (logo) and 1345626727. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
