## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 18ct yellow gold and 18ct white gold, diamond set, multistone ring, of hand crafted construction.

Plain, narrow, flat, tapered band of 1.47mm width (at base) x 0.79mm depth.

Feature central white gold six claw setting, housing one round brilliant cut diamond, claw set. The central setting is secured between the yellow gold shoulder plates, in a 'scroll' form. Each of the shoulders also has one white gold four claw setting, sitting on top of the 'scroll', housing one single cut diamond, claw set. The central setting and shoulder plates are attached to the top of the plain and polished yellow gold band.

Polished finish.

Stamped '750' - acid tested as 18 carat gold.

Ring size: T.

The ring contains:

- One claw set round brilliant cut diamond, clarity is "Si", colour is "G".  
Dimensions = 3.11mm(Dia) x 1.90mm(D-estimated) x 2%(Girdle Thickness)  
Total Weight = 0.11ct (estimated - see NOTE below)
- Two claw set single cut diamonds, clarity is "Vs & Si" (mixed), colour is "H to J" (mixed).  
Dimensions (average) = 1.30mm (diameter)  
Total Weight = 0.02ct (estimated - see NOTE below)

Total Item Weight = 2.60 grams  
Total Gemstone Weight = 0.13ct  
Total Metal Weight = 2.57 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
