Valuation for Traditional Retail Insurance Replacement

One lady's, hand finished, raised 9ct rose gold & diamond set, cluster ring. Plain, narrow, low half round, tapered band, measures 2.10mm width (at base) x 1.03mm depth, with curved

Feature; "cluster style" ring design. Comprising, a raised cluster setting to top, rhodium plated to highlight. The extended shoulders, of the band tapers up to support the cluster setting, from

Polished finish, stamped "375" - acid tested as 9 carat gold. Finger size = L.



The ring contains;

Seven claw set round brilliant cut diamonds, clarity is "P1 & P2" (mixed), colour is "G to H" (mixed), medium cut quality.

Dimensions = 2.30mm (average diameter) x 1.40mm (D-estimated)

Total Weight = 0.32ct (estimated - see NOTE below).

Twenty claw set round brilliant cut diamonds, clarity is "P1 & P2" (mixed), colour is "G to H" (mixed), medium cut quality.

Dimensions = 1.32mm (average diameter) x 0.81mm (D-estimated)

Total Weight = 0.18ct (estimated - see NOTE below).

Total Item Weight = 2.84 grams, Total Gemstone Weight = 0.50ct, Total Metal Weight = 2.74 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
