## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, hand-assembled, 10ct yellow gold and 10ct white gold, multistone, gem set ring.

Plain, narrow, tapered band of 2.30mm in width (at base) x 0.89mm depth, with curved underrail, cut-out section at the shoulders.

Feature central four claw railed setting, housing one round brilliant cut diamond, claw set. Secured between the extended shoulders of the plain and polished band. Each shoulder having five round brilliant cut diamonds, tapering in size, channel set.



Polished finish - stamped '417 MHJ 0.25TDW' - acid tested as approximately 10 carat gold. Finger size is P.

The ring contains:

One claw set round brilliant cut diamond, clarity 'P1', colour 'H'.

Dimensions = 3.38mm(Dia) x 2.06mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.15ct (estimated - see NOTE below)

Ten channel set round brilliant cut diamonds, clarity 'Si & P1' (mixed), colour 'I to J' (mixed).

Dimensions = 1.10mm to 1.35mm(Dia) x 0.79mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.10ct (estimated - see NOTE below)

Total Item Weight = 2.38 grams - Total Gemstone Weight = 0.25ct - Total Metal Weight = 2.33 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
