Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's 2pce set, hand-assembled raised, 9ct white gold & diamond set, multistone rings. Plain, narrow, low half round, tapered band, a combined basal width 2.68mm x 1.06mm depth, with curved underrail.

Feature; "2pce ring set". Comprising, engagement ring, a raised six claw illusion setting to top, houses one round brilliant cut diamond. The extended shoulders, of the band tapers up, crosses over, each shoulder contains five round brilliant cut diamonds, tapering sizes, channel set. A contured, lock in fitted side band, v-shaped row style, contains eleven round brilliant cut diamonds, channel set.



Polished finish, stamped "9K,9K" - acid tested both as 9 carat gold.

Finger size P.

The ring set contains;

One illusion claw set round brilliant cut diamond, clarity is "P1", colour is "J", medium cut quality.

Dimensions = 2.74mm (Diameter) x 1.67mm (D-estimated)

Total Weight = 0.07ct (estimated - see NOTE below).

Twenty One channel set round brilliant cut diamonds, clarity is "P1 & P2"(mixed), colour is "I toJ & light brown tint", medium cut quality.

Dimensions = 1.53mm (average diameter) x 0.93mm (D-estimated) (smallest)

Dimensions = 2.09mm (average diameter) x 1.27mm (D-estimated) (largest)

Total Weight = 0.53ct (estimated - see NOTE below).

Total Item Weight = 4.99 grams, Total Gemstone Weight = 0.60ct, Total Metal Weight = 4.87 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar 2pce ring set, employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
