## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 9ct yellow gold, diamond set, multistone ring, of cast construction.

Plain, narrow, low half round, tapered band of 2.36mm width (at base) x 1.07mm depth, with a hollow top and shoulders, and open back settings.

Feature four diagonal rows of three round brilliant cut diamonds, spanning across the top of the band, and channel set. The settings are secured between the shoulders of the plain and polished band.

Polished finish.

Stamped '375 E' - acid tested as 9 carat gold.

Ring size: N 1/2.

The ring contains:

Twelve channel set round brilliant cut diamonds, clarity is "P1 & P2" (mixed), colour is "light tinted brown to tinted brown" (mixed).

Dimensions = 1.67mm(Dia) x 1.02mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.90mm(Dia) x 1.16mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.30ct (estimated - see NOTE below)

Total Item Weight = 3.00 grams

Total Gemstone Weight = 0.30ct

Total Metal Weight = 2.94 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
