### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One pair of, 10ct yellow gold and 10ct white gold, diamond set, multistone, stud earrings, of hand-assembled construction.

Feature round white gold top plate, within a yellow gold railed four claw setting. Each top plate houses eleven round brilliant cut diamonds, claw set. The earrings are finished with post and butterfly attachments.

Earring dimensions = 6.43mm (ave. length) x 6.41mm (ave. width) x 4.49mm (ave. depth).

Polished finish.

Stamped '10K(butterfly)' - acid tested as 9 carat gold.

The earrings contain:

Twenty Two claw set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "I to J" (mixed).

Dimensions = 1.05mm(Dia) x 0.64mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.05mm(Dia) x 1.25mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.50ct (estimated - see NOTE below)

Total Item Weight = 1.80 grams

Total Gemstone Weight = 0.50ct

Total Metal Weight = 1.70 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pair of earrings employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
