## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 9ct yellow gold and 9ct white gold and rhodium plated, diamond set, multistone, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 1.72mm width (at base) x 1.04mm depth, with a hollow top and shoulders, open back settings, and a curved underrail.

Feature central white gold, square top plate within a four claw setting, housing four round brilliant cut diamonds, claw set. The setting is secured to the underrail, and in between the extended and square shoulders, of the plain and polished yellow gold band. Each of the sholders houses one row of six round brilliant cut diamonds, varying in size, and claw set. Rhodium plating to the setting areas.

Polished finish.

Stamped '375 JP88' - acid tested as 9 carat gold.

Ring size: Q.

The ring contains:

Four claw set round brilliant cut diamonds, clarity is "Vs & SI & P1" (mixed), colour is "H to J" (mixed).

Dimensions (average) = 2.20mm(Dia) x 1.56mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.16ct (estimated - see NOTE below)

Twelve claw set round brilliant cut diamonds, clarity is "Vs & Si & P1" (mixed), colour is "H to J" (mixed).

Dimensions (average) = 1.62mm(Dia) x 0.99mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.22ct (estimated - see NOTE below)

Total Item Weight = 1.82 grams Total Gemstone Weight = 0.38ct Total Metal Weight = 1.74 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
