Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct yellow gold and rhodium plating, gem set, 'cluster' style ring, of cast construction.

Plain, narrow, low half round band of 1.79mm width (at base) x 0.94mm depth, with a hollow top and shoulders, open back settings, and a curved underrail.

Feature central four claw setting, housing one emerald cut natural emerald, claw set. Surrounding is one row of twenty-four single cut diamonds, and each of the shoulders houses one row of eight single cut diamonds, all claw set. The top plate is supported with a decorative gallery, and is secured in between the extended and square shoulders, of the plain and polished band. Rhodium plating to the setting areas.



Polished finish.

Stamped '375 TW' - acid tested as 9 carat gold.

Ring size: O.

The ring contains:

One claw set emerald cut natural emerald, colour is "green".

Dimensions = 7.03mm(L) x 5.02mm(W) x 3.22mm(D-estimated)

Total Weight = 0.77ct (estimated - see NOTE below)

Forty claw set single cut diamonds, clarity is "Vs & Si", colour is "light tinted brown".

Dimensions (average) = 0.90mm (diameter)

Total Weight = 0.16ct (estimated - see NOTE below)

Total Item Weight = 2.28 grams Total Gemstone Weight = 0.93ct Total Metal Weight = 2.09 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
