Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold, diamond set, multistone ring, of handmade construction.

Plain, narrow, low half round band of 2.46mm width (at base) x 0.99mm depth, with open back settings, and a curved underrail.

Feature central four claw setting, housing one round brilliant cut diamond, claw set. The central setting is secured to the underrail, of the plain and polished band. Each of the shoulders houses one row of three round brilliant cut diamonds, claw set.



Polished finish.

Stamped '750' - acid tested as 18 carat gold.

Ring size: M.

The ring contains:

One claw set round brilliant cut diamond, clarity is "Si2", colour is "E".

Dimensions = 5.93mm(L) x 5.87mm(W) x 3.71mm(D-estimated) x 4%(Girdle Thickness)

Total Weight = 0.80ct (known weight - see NOTE below)

Six claw set round brilliant cut diamonds, clarity is "Si", colour is "G to H" (mixed).

Dimensions (average) = 2.34mm(Dia) x 1.43mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.30ct (estimated - see NOTE below)

Total Item Weight = 4.59 grams Total Gemstone Weight = 1.10ct Total Metal Weight = 4.37 grams (estimated)

NOTE: The diamond has been certified by Messrs. Gemological Institute of America (GIA) Certificate number: 1129194789 Dated: Jun 08, 2011. The diamond has also been laser inscribed upon the girdle with GIA (logo) and 1129194789. No diamond certificate or paperwork was presented at the time of this valuation. Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
