## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 14ct white gold, gem set, 'cluster' style ring, of cast construction.

Plain, narrow, low half round, tapered band of 2.06mm width (at base) x 0.99mm depth, with open back settings, and a curved underrail.

Plain, central square setting, housing four Princess cut diamonds, invisibly set. Surrounding is one row of twelve round brilliant cut diamonds, claw set. The top plate is secured to the upswept shoulders, of the plain and polished band. Each of the shoulders houses one row of four round brilliant cut diamonds, graduating in size, and claw set. The edges of the top plate, shoulders, and underrail are embellished with a low relief pattern and millegrain detail.

Polished finish.

Stamped 'Q6 14K michael hill' - acid tested as 14 carat gold.

Ring size: O.

### The ring contains:

Four invisibly set Princess cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "H to I" (mixed).

Dimensions (average) = 2.90mm(L) x 2.90mm(W) x 2.06mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.56ct (estimated - see NOTE below)

Twenty claw set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "H to I" (mixed).

Dimensions = 1.90mm(Dia) x 1.16mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.50mm(Dia) x 1.53mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.60ct (estimated - see NOTE below)

Total Item Weight = 5.34 grams Total Gemstone Weight = 1.16ct Total Metal Weight = 5.11 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
