Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand finished, raised 18ct yellow gold & diamond set, multistone ring.

Plain, narrow, low half round, tapered band, measures 2.34mm width (at base) x 1.09mm depth, with curved underrail.

Feature, "solitaire style" ring design, with shoulder stones. Comprising, a raised six claw coronet to centre, houses one round brilliant cut diamond, claw set. The extended shoulders, of the band, tapers up, curl/wraps to each side of the coronet. The shoulders, contain five round brilliant cut diamonds, tapering sizes, channel set, both sides.



Polished finish, stamped "MHJ, 18ct,.34" - acid tested as 18 carat gold. Finger size = O.

The ring contains;

One claw set round brilliant cut diamond, clarity is "Si", colour is "H", medium cut quality.

Dimensions = 3.79mm (average diameter) x 2.20mm (D-estimated)

Total Weight = 0.20ct (estimated - see NOTE below).

Ten channel set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "H to I"(mixed), medium cut quality.

Dimensions = 1.35mm (average diameter) x 0.82mm (D-estimated) (smallest)

Dimensions = 1.60mm (average diameter) x 0.98mm (D-estimated) (largest)

Total Weight = 0.14ct (estimated - see NOTE below).

Total Item Weight = 3.84 grams, Total Gemstone Weight = 0.34ct, Total Metal Weight = 3.77 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
